

OFFICIAL RULES

The limited liability amateur sports club RCS Active Team a r.l., affiliated with OPES Lombardia, organizes the third edition of the Milano Family Run, officially called "**Family Run 2026**", a non-competitive run/walk, over a distance of about 4 km for children and young people, families and their companions.

The race will take place **on Saturday 11 April 2026** in Milan starting from Via Arona and finishing at the Maspes Vigorelli Velodrome, and will take place in all weather conditions. The event may be cancelled due to circumstances beyond our control in accordance with the provisions of the local authorities.

The **registration of participants under the age of 18** must be made by an adult exercising parental authority. Participation **of persons under the age of 14** must be under the supervision and responsibility of an accompanying adult. Each participant must be in good health, which means not having pathologies that compromise the psycho-physical balance of the individual in everyday life and therefore allow him to participate safely in the event.

OPENING AND CLOSING OF REGISTRATIONS

Online registration will be open until midnight on April 10. S.S.D. RCS Active Team a r.l. reserves the right to close registrations early or to accept registrations after the closing date at its sole discretion.

REGISTRATION FEE

The registration fee is:

€ 10.00 per participant for single registrations for both adults and children/teenagers.

€ 9.00 per participant for group registrations (from 3 people upwards) for both adults and children/teenagers.

For each paid enrolment and with preference for a regularly expressed school, **half of the fee will subsequently be returned to the school.**

The registration fee does not include the cost of the service.

THE REGISTRATION FEE INCLUDES:

- race bib;
- RCT insurance;
- technical and medical assistance;
- event t-shirts for children and adults;
- medal of the event for all participants;
- final refreshment.

HOW TO REGISTER

Registration must be made online, following the instructions on the milanomarathon.it website.

- Direct registration through the registration portal by making online payment by credit card.
- Payment can be made by VISA or MasterCard credit card

The service fee of 1 euro for each registration is not included in the registration fee. The service fee does not apply to free memberships.

The cost of the service includes:

- the sending of communications by the organizer with technical information on the event
- the management of the registration and any changes requested by the participant
- the use of the registration platform

REIMBURSEMENT OF PARTICIPATION FEES

Registration is neither deferrable nor transferable to another person.

BIB AND RACE PACK COLLECTION

In the case of **direct** registration, the registered must personally collect their bib.

In the case of registration **through the school**, the school contact person will collect all the school's bibs and race packs, by appointment with the organization.

Information will follow regarding the methods and place of collection of the race bib and the race pack.

DEPARTURE

The start of the Family Run will take place from **via Arona**. From 9:00 onwards, "waves" of about 400 people will be started, spaced out by 10 minutes. On each bib will be indicated the recommended time to arrive at the starting area, based on the assigned starting wave. The race will take place mainly within City Life on a route entirely closed to car traffic.

HEALTH SERVICE

The organization will arrange an adequate medical assistance service on the route and at the starting and finishing points.

ATHLETE RESPONSIBILITY

The registered runner, or the parent in the case of a minor, is responsible for the ownership and custody of his/her race bib, acquiring the right to use all the services mentioned in these regulations and subsequently communicated.

a. Anyone who, without regular registration, participates without a bib may be liable to criminal sanctions provided for the crime of "theft" (art. 624. of the Italian Civil Code).

b. Anyone, without regular registration, participates with a counterfeit or otherwise non-compliant bib to the assignment, in addition to being responsible as indicated above, may be liable to criminal sanctions provided for the crime of "theft" (Article 624 of the Criminal Code), or, alternatively, for the crime of fraud (Article 640 of the Criminal Code).

In cases a) and b) the participants may be liable to the penalties provided for the crime of "non-compliance with the measures of the Authorities" (Article 650 of the Criminal Code). The above cases will be found only after verification of photographic and/or video documentation.

FINAL WARNINGS

The Organizing Committee reserves the right to modify these regulations at any time for reasons it deems appropriate for a better organization of the race. Any changes to services, places and times will be appropriately communicated to the registered athletes or will be reported on the website milanomarathon.it/family-run/



DISCLAIMER

By registering for the Family Run 2026, I declare that I am aware of and comply with these regulations which will be published on the milanomarathon.it/family-run/ website.

I am aware that participating in the Family Run 2026 and/or sporting events in general is potentially a risky activity. I also declare that I register voluntarily and I am also responsible in the case of registration of the minor, of whom I am a parent or legal guardian, carried out by me. I assume all risks arising from my participation in the event: falls, contact with vehicles, other participants, spectators or other, weather conditions, including scorching heat, extreme cold and/or humidity, traffic and road conditions, any type of risk well known and assessed by me and any consequences deriving from illness and/or injuries suffered or caused to myself or third parties, also attributable to the unsuitable physical condition, which may occur during and after participation in the event. I hereby declare that I waive, now and for the future, on my own behalf and on behalf of the child for whom I am a parent or responsible, any claim for compensation and compensation in connection with the foregoing. I raise and free, to the fullest extent allowed by the mandatory regulations in force, the Family Run 2026 Comitato Organizzatore, S.S.D. RCS Active Team a r.l., RCS Sports & Events Srl, the sponsoring organisations, Amministrazione Comunale di Milano, Amministrazione Provinciale di Milano, Amministrazione Regionale della Lombardia, OPES, all the Sponsors and Partners of the event, their respective representatives, successors, officers, directors, members, agents and employees of the above-mentioned Companies, of all present and future claims or liabilities of any kind, known or unknown, arising from my participation in the event and that of those who participate under my responsibility.
